Sustainability Policy

Introduction

This policy statement sets out ACE's aims for aiding sustainable development. ACE is committed to implementing actions to deliver the aims set out below. These actions will promote and embed sustainable development in all aspects of our activities.

Buildings and Estate

- Ensure that ACE's business is conducted in a manner that improves energy efficiency and seeks to eliminate waste.
- Embed the principles of sustainability in the design of new buildings and building systems.
- Ensure that the management of existing buildings minimizes the environmental impact of the energy consumed.
- Promote the use of more sustainable modes of transport by encouraging staff and students to use public transport, car share and cycling to attend a Centre.
